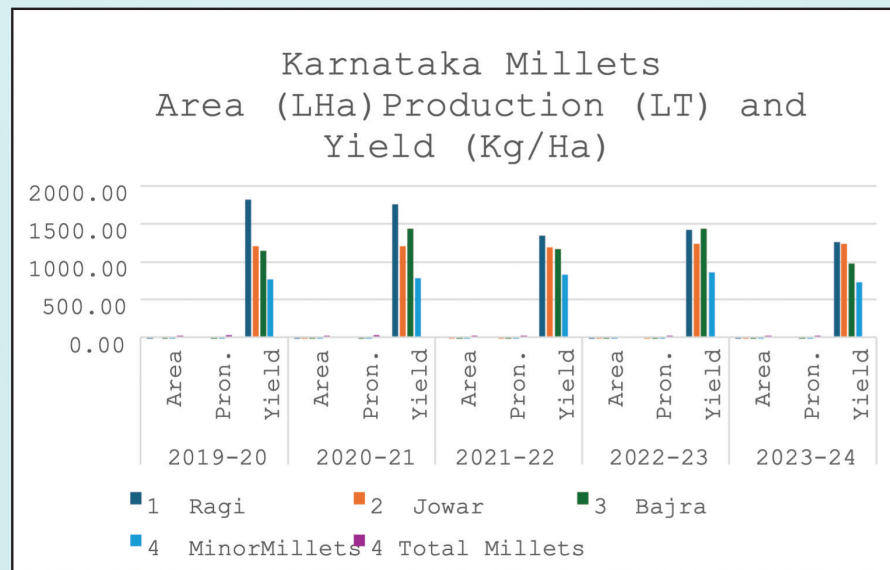

Introduction - Millets

Karnataka is a significant producer of millets in India. According to the data available (refer the chart below), the state's millet production and yield has constantly been good.

Production and yield of millets in Karnataka can be affected by various factors such as climate change, soil quality, and farming practices. The state has over the years adopted several progressive measures to improve the production and yield of millets.



These include adoption of

- Promoting sustainable farming practices and improve soil health : This includes crop rotation, organic farming, and efficient irrigation systems to enhance millet yields and reduce environmental degradation.
- Developing climate-resilient crop varieties. The state ecosystem is encouraging farmers to adopt high-yielding millet varieties, such as finger millet (ragi) and small millets (like navane and savi), which have shown promising results in Karnataka.

Further, the state government is encouraging support for enhancing Millets production by implementing policies and programs that support millet cultivation.

This includes

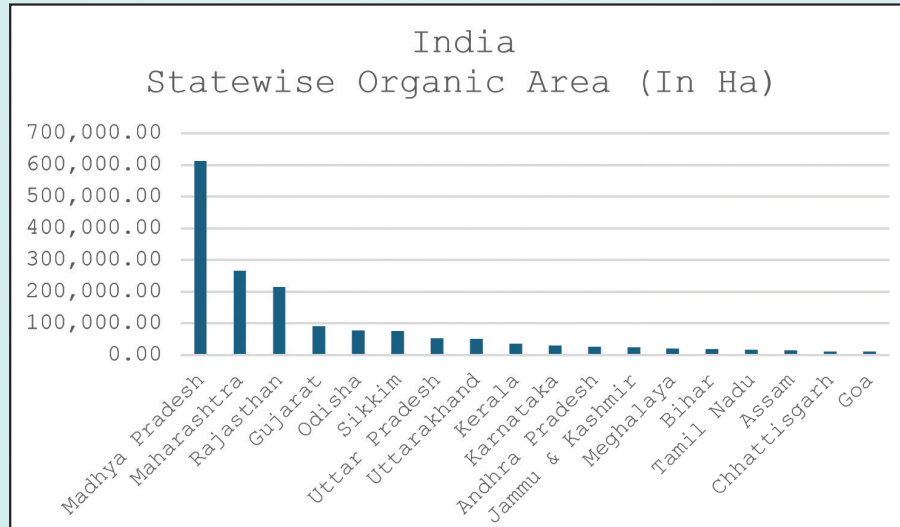
- Value Chain Development to strengthen the millet value chain by supporting processing, storage, and marketing infrastructure. This is helping increase farmers' incomes and encourage them to cultivate millets.
- Market Promotion to raise awareness about the nutritional benefits and culinary uses of millets to increase demand and promote market growth.
- Other measures include providing subsidies, credit facilities, creation & support for farmer federations and technical assistance to farmers.

Introduction - Organics

Karnataka has been actively promoting organic farming, and the state has seen significant growth in organic production.

According to various studies, organic farming in Karnataka has resulted in higher yields and better crop quality. The state has seen increased yields with several farmers reporting higher yields after switching to organic farming methods. Organic farming has also led to improved crop quality, with farmers reporting better taste, texture, and nutritional value. Organic farming has the potential to provide higher returns to farmers due to premium prices for organic produce.

Challenges



There are some challenges towards shifting to organic farming. The higher cost of production for organic farming compared to conventional farming is a major deterrent. One of the other challenges faced by organic farmers in Karnataka is yield reduction, especially during the conversion period from conventional to organic farming. Organic farming requires certification, which can be costly for small-scale farmers. This can be a barrier to adoption for some farmers.

The state government is well aware of these challenges and has taken several progressive measures to ensure the sustainability and scalability of organic farming in the state. These include Organic Farming Policy which provides incentives and support to organic farmers; offering subsidies and grants to farmers to adopt organic farming practices and Training and Capacity Building programs for farmers, extension workers, and other stakeholders.

There is a growing demand for organic produce in Karnataka and India, driven by increasing consumer awareness and preference for healthy food. Karnataka intends to tap into the national and global organic market, with the state's organic produce being exported to countries like the US, Europe, and Middle East as also other parts of the country. The state also intends to developing local markets for organic produce to help increase sales and provide better returns to farmers. Many Agtech and Fintech companies have their operations in the state. They are in the form of value chain companies, start-ops and post start ups with technology based business integration.
